Dear Sir,

On August 18 this year, citizen Gaweł Rafał from the Center for Monitoring Racist Behavior wrote on his Facebook and X profile: "The District Prosecutor's Office in Warsaw received our notification of a crime committed by patostreamer Mariusz Kolonko.

In the notification, we demanded the initiation of an investigation and the initiation of an international search along with an extradition request (original spelling) (...) According to the information we obtained, Mariusz Kolonko, alias "Max", will be immediately detained if he tries to enter Poland or any of the European Union countries. "

This message contains a suggestion that this "information" comes from you as the Spokesperson of the District Prosecutor's Office in Warsaw, where this notification was allegedly reported.

Please explain:

1. Who personally in PO Warsaw is dealing with the case of the denunciation of citizen Gaweł and who from the Prosecutor's Office is in contact with the organization headed by citizen Gaweł?
2. Did the information contained in the above-mentioned post about the arrest of American citizen Max Kolonko in the event of his arrival in Poland or the European Union come from you?
3. Does the District Prosecutor's Office in Warsaw have any connection with providing this "information"? What is the current status of the OZMRIK denunciation against Mr. Max Kolonko?
4. Is the information spread in the Polish media that an organization called HejtStop also filed a report on Max Kolonko true? If so - what is the subject of this report?

5. Was Max Kolonko convicted in absentia by a final judgment in the above case? Is the false report of citizen Gawel from OMZRK vs. Max Kolonko still the subject of "explanatory activities" by PO in Warsaw?
6. As reported by citizen Dominik Senkowski from the portal z Wirtualne media on 2023 - 12 - 08, the Spokesperson of the District Prosecutor's Office in Warsaw gave the following information: "the proceedings are still ongoing. Witnesses are being questioned". Is this true? What "witnesses" are you talking about here, considering the journalist's statement on private television?
7. Do you and the District Prosecutor's Office in Warsaw know that Max Kolonko has not received any information in this case from the Prosecutor's Office apart from the revelations published in the Polish media suggesting that the information came from PO Warsaw?
8. Are you and the District Prosecutor's Office in Warsaw aware that citizen Gawel Rafał is wanted by the Polish Police on an arrest warrant and is hiding in Norway at the address Frederik Stangs, Gate2 Oslo, Norway?
9. Do you and the District Prosecutor's Office know that citizen Gawel's report is false, unfounded and based on a 10-second fragment of a 55-minute program by Max Kolonko, stolen from the private television MaxTV, devoted to the brutal murder of 21-year-old Ola from Legnica, who was run over to death by 3 drunk Ukrainians, and the issue of the statement regarding the responsibility and punishment for citizen Andrzej Duda for this brutal and unnecessary death falls within the scope of the journalist's freedom of speech?
10. Do you not think that citizen Gawel from Norway, a criminal prosecuted for fraud and extortion, freely throwing Polish patriots into prisons based on false denunciations, ridicules and discredits the Polish Prosecutor's Office under the government - previously - of Jarosław Kaczyński and now of Donald Tusk?
11. Do you and your superiors realize that the maintenance of this nonsensical investigation by the Prosecutor's Office serves political forces hostile to Poland to build an atmosphere in the Polish media conducive to the murder of politicians and that, as Max Kolonko wrote to former Minister of Justice Zbigniew Ziobro in a letter dated August 27, 2023 - "Your anger and hatred have thus led to the promotion of the crazy concept of murdering politicians in the Nation. And you will be responsible for future events, if they occur."?
